WHY JUSTICE?

A NEW APPROACH FOR A CHANGING WORLD



Despite massive advances in technology and science and huge aid budgets, most people on the planet don't reap the harvest promised by economic growth.

Although there have been some small gains, much of the 'development' over the past few decades has created an ever-growing gap between rich and poor, environmental destruction on an unprecedented scale and immeasurable human rights abuses that hold up our broken economic and social systems.

While humanitarian and development organisations, environmentalists and national governments continue to strive for a better future for the next generations, it is clear that what we are doing is not enough. Something must change. We must work together in new ways to strive for something more than simply development. We must start to shift historical power dynamics and start to work towards justice.

It's been 25 years since human rights based approaches were introduced. A Justice Based Approach tackles some of the gaps we already know exist and pushes beyond simple fulfillment of rights to aiming for something far greater and far more profound. It actively addresses broken systems and systemic causes and holds those responsible for human and environmental catastrophes to account. It starts with ourselves and our own organisations re-aligning to the causes we claim to lead. It's about ensuring that those most affected are those most involved in decisions and no longer looking to outdated, surface solutions to some of the world's most pressing problems. It provides tools for critical-thinking, leadership, and strategic design.

We will critically challenge and explore many assumptions about methodology and practice in the following areas:

- Strategic Leadership
- Programme Design
- Evidence-based decision making
- Participatory Approaches
- System Analysis
- Privilege and Power
- Rights Based Programming
- Monitoring and Evaluation for Learning
- Ethics and Accountability

We will also explore a number of innovative and exciting practical approaches that you can apply to your work.

The training will challenge you, inspire you and give you the tools to lead environmental, social change, development and humanitarian work that is truly transformative.

PARTICIPANTS

This training is designed for leaders and potential leaders of development and humanitarian agencies, as well as anyone that wants to create positive social change or environmental impact in their work, life and community. We welcome participants from all levels of organisations and from diverse departments to the training, which creates a rich mix of experience and perspectives.

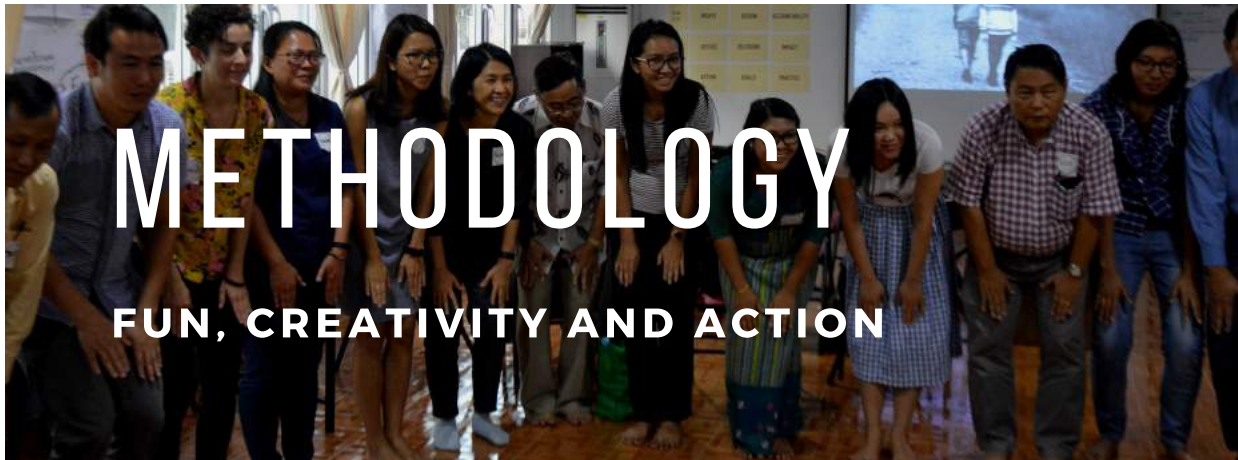

With years of experience in education, training and facilitation, the United Edge team are extremely proud of the responses we receive from participants about both the content and methodology of the Better Development training programme. In the words of Daniel Bevan, Director of United Edge, "From the moment the training begins we take each group on a journey into the world of social change. From learning about the history of development and human rights to exploring system analysis and how to develop the most effective indicators for our work, every part of this training leads to the next."

The training is divided into twelve 105 minute sections, each with a specific theme that builds upon the previous sessions.

We use reflection, games, lecture, videos, movement, music, group discussion, tasks, presentations and even mindfulness techniques in our sessions. Every part of the methodology is designed to support people to think critically and creatively.

Additionally, we provide an engaged community, ongoing learning calls and the potential for collaboration long after the training ends -- meaning that the learning is contextualized and put into action by participants in their own work.

TRAINING FEES

The training fee is \$450 USD per person for the three day training, which includes:

- Three full days of training led by highly experienced facilitators
- Better Development Resource Pack containing notes from every session and a pre-prepared presentation and session plan to share back with your team
- Ongoing access to our online community of social change makers, including optional quarterly Learning Calls for ongoing professional development
- Lunch and two refreshment breaks each day

A 10% discount is available when you book 10 or more places on a single training.

Groups can be from multiple organisations, provided they book the training together. Donors and organisations have used this as an opportunity to support partners to attend.

The "Better Development: A Justice Approach" training was launched in May 2017 -- first as a pilot to test the model and then scaled-up based on the positive feedback and results. In 15 months, we have trained people from 202 organisations at 25 separate trainings in 12 countries across Asia. This is what our participants said in 2018:

- **98%** of participants would recommend the training to others working for social change
- **89%** of participants now feel able to put their beliefs and passions into action in everyday life
- **98%** of participants are satisfied or greatly satisfied with the training content and facilitation
- **76%** of participants have used aspects of the Justice Based approach in their work since finishing the training
- **95%** of participants agree or strongly agree that the training helped them see things in a new way

In addition, participants have rated us an average of 6 out of 7 for good value for money and 6.1 out of 7 for relevance to their work. We now have 364 participants as part of our growing online community, forming a learning group for ongoing professional and personal development.
